Between May 2012 and October 2015 Mr. Limbrunner was combined CTO and COO and subsequently CTO until November 2016. From December 2016 until February 2018, he was Head of the Mobile Business Unit, then between February 2018 and October 2022 he was Director of Sales and Marketing. Since November 2022 had been occupying the newly created Directorship of Governmental Affairs & Communication.
